APPLYING FOR CREDIT

1. No personal credit account applications will be accepted.
2. All accounts must be under a business name and applicants must have a business checking account or business license.
3. All applications will take a minimum of three weeks to process. Applicants will be notified by phone/mail of their account status.
4. Applications left incomplete will not be processed.
5. California Stage & Lighting, inc. will reserve the right to review all accounts quarterly and may close an account, without notification, which does not meet these credit requirements:
 - a. \$150.00 minimum volume of business per month.
 - b. Business license or checking account maintained in good standing.
 - c. All accounts paid promptly and within invoice terms.
 - d. All claims against California Stage & Lighting, inc. must be justified.

TERMS AND CONDITIONS

1. 25.00 minimum account charge for billing.
2. Terms are NET 15 (unless customer is otherwise notified)
3. All prices are quoted FOB Santa Ana, California in U.S. Dollars.
4. Customer is to pay all costs of transportation, insurance, taxed (including California Sales Tax on all orders delivered in the state of California), license fees, customs duties and other charges related to the sale or rental of equipment and supplies. These charges shall be added to the Customer's invoice and become a part of the total due on the same basis set forth above.
5. After set terms from date of invoice the full balance on that invoice will bear a service charge of one and one half percent (1 ½ %) per month until paid in full.
6. If a discount is issued on an invoice and that invoice becomes past due, the Customer can be held responsible for the full list price of that invoice.
7. If orders at discounted prices are delayed due to past due accounts, higher prices will apply after the date prices are increased.
8. No credit purchases will be allowed, or shipment made, if an account is past due.
9. California Stage & Lighting, inc. reserves the right to repossess equipment or supplies sold or rented to Customer on its default in payment thereof.
10. California Stage & Lighting, inc. will hold a security interest in all items sold to Customer pending full payment on its default in payment thereof.
11. Customer will be held liable for all costs of collection including reasonable attorney's fees incurred as a result of the failure to comply with any terms to this agreement.
12. All cancellations of confirmed rentals are subject to approval by management and to a 15% restocking fee. All sale returns are subject to approval by management and to a 20% restocking fee. Account Customers will be issued Credit Memos only, to be applied to future invoices. California Stage & Lighting, inc. does not accept returns on any expendable supplies (i.e. gel, lamps, tape, fog fluid, makeup, etc.)
13. Rentals confirmed with less than 24 hours notice are not subject to discounting.
